Members of the Board of Directors of the Authority may attend in person, by video or internet connection, or by telephone call.

The Industrial Development Authority of the County of Pima further reserves the right to hold special meetings, the notice for which will be posted (both physically and electronically) as set forth below. Such special meeting may or may not be at the same time or location noted above; however, the notice for a special meeting (as posted) will contain the time and the location for such special meeting.
